# No infra in colleges, K'taka to lose 2,410 UG medical seats

Bengaluru: In a major blow to students who want to study medicine, the state is all set to lose at least 1,210 undergraduate medical seats for academic year 2018-19 after the Medical Council of India refused renewal sanctions to eight medical colleges, as per documents released by the Union health ministry.

However, experts said the loss of medical seats in the state is even higher—at least 2,410 seats—since MCI has also denied sanction to eight new colleges. Seven of these new colleges are state-run and the lone private one would have added another 1,200 seats to the state's kitty.

State-run Koppal Institute of Medical Sciences (KIMS), which has 150 UG medical seats, isone of the eight colleges denied permission. Of the other seven, four are private medical colleges from Bengaluru — including St John's Medical College & Hospital—and one each from Vijayapu-

ra, Kolar and Tumakuru.

Sources said lack of sufficient staff, deficiency in clinic material, infrastructure and key posts being vacant were some issues raised by MCI during its inspection of colleges earlier this year. But, some colleges, including St John's, say they may move court while others are hopeful of securing permission by August.

### Fee hike of up to 8% for professional courses

Regulatory panel sets the ceiling

The fee regulatory committee, appointed by the government, has recommended a fee hike of up to 8% from the previous year for professional courses. This will be applicable for all medical, dental and engineering colleges for the 2018-19 academic year.

D.V. Shylendra Kumar, committee-chairman and former High Court judge, said that he conducted a meeting with private professional institutions from March 12 to March 19, "The fee fixed by the committee will act as an apper limit and ceiling," he said, adding that private institutions have the option to charge a fee lower than that fixed by the committee. In the proceedings to the colleges, the committee has allowed reasonable surplus required for the growth and the development of the institutions.

The committee has determined the fees only for institutional quota seats. He also pointed out that the seat matrix and the seat-sharing arrangement of private colleges with the government will, however, not change.

Although some colleges had projected a higher increase in expenditure, the committee was not inclined to accept the proposed fee, on the grounds that the pro-

posals are not "sustainable".

The committee has also raised objection to the manner in which consensual agreement has been entered into with private professional institutions, and noted that the fixing of fees was the function of the fee regulatory committee. "Even if the government signs the consensual agreement, it will have to fix the fee based on the ceiling recommended by the fee regulatory committee," he said. He added that government and private colleges have no choice but to implement this fee structure. "It was binding on the government to comply with it," he said.

#### NRI fee

The committee this year has also fixed the NRI students' fee which is 10 times the fee fixed for local students. Earlier, the State government had not fixed any cap for fees collected from NRI students.
